

INFORMATION CLAUSE REGARDING THE USE OF COOKIES

3. **Purpose of processing** Personal data processed as part of cookies are used for the following purposes:
 - ensuring the proper functioning of the website,
 - improving the functionality and comfort of using the website,
 - analysis of website traffic and user behavior in order to improve content and services,
 - personalization of content and matching it to user preferences,
 - operating statistical and marketing tools.
4. **Legal basis for processing**
 - Article 6(1)(a) of the GDPR – the user's consent to the processing of personal data for marketing and analytical purposes,
 - Article 6(1)(f) of the GDPR – the legitimate interest of the controller consisting in ensuring the security, proper functioning of the website and its optimisation.
5. **Types of cookies**

We use the following types of cookies on the Foundation's website:

 - **Essential:** to enable the website to function properly, e.g. remembering user preferences.
 - **Functional:** allowing you to save user settings and preferences, e.g. the choice of website language.
 - **Analytical:** used to collect information about how the website is used in order to improve its functioning.
 - **Marketing:** To show you ads that are tailored to your interests.
6. **Recipients of personal data**

The data collected by cookies may be transferred:

- providers of analytical and marketing tools (e.g. Google Analytics, Facebook Pixel),
 - hosting and technology service providers,
 - partners supporting Sano in conducting marketing and analytical activities, in accordance with the principles of data security.
7. **Period of storage of personal data**

Personal data collected through cookies are stored:

- for the time specified in the cookie settings (depending on the type of cookies – session or permanent),
- until the user withdraws their consent (applies to cookies that require consent).

8. Rights of the data subject

Persons using the Foundation's website have the right to:

- access to your data,
- rectify data,
- delete data (to the extent that the data results from the use of cookies and are not necessary for the proper functioning of the website),
- restriction of processing,
- object to the processing of data for marketing or analytical purposes.

9. Right to lodge a complaint with a supervisory authority

Data subjects have the right to lodge a complaint with the President of the Office for Personal Data Protection if they believe that the processing of data violates the provisions of the GDPR.

10. Managing cookies

The user can manage cookies through the settings of their web browser, including:

- accepting or rejecting cookies,
- deleting stored cookies,
- Blocking certain types of cookies. For information on how to change your browser settings, see your browser documentation.

11. Consequences of not consenting to cookies

Refusal to accept cookies may limit some of the functionalities of the website or prevent its full use.
